  - Can choose to access until 21 years of age
- Supports continue to be determined by a budget
  - Can choose services through a DDA or Family Directed Services
  - Continue to write supports plan with Department case manager

### Screening for Intervention Services

- Because intervention services do not require a developmental disability diagnosis, a screening is used to determine a child has a need for intervention.
- Screening process will determine if a child has deficits in any of the following area(s):
  - Self-care, receptive and expressive language, learning, mobility, self-direction, capacity for independent living, or economic self-sufficiency
- A child age 0-21 whose screening shows a deficit in at least three (3) of the above areas will be able to access intervention services.

# Assessment and Clinical Treatment Plan

- Similar to the HI Evaluation completed today
- Completed with the family by the child's chosen intervention provider
- Includes observations, review of records and other services, assessments, etc.
- Results in a recommendation of hours of intervention a child needs that is submitted for prior authorization.

### Eligibility for Supports Services

- Support Services will continue to require a developmental disability diagnosis.
- Eligibility will continue to be completed by the Independent Assessment Provider (Liberty Healthcare)

  - Independent Specialist Bachelor's degree, 1040 hours of experience, meets competency requirements, and holds a Medicaid Provider Agreement.
    - Can provide habilitative skill, behavior intervention, family training, and interdisciplinary training.
  - Independent Professional Master's degree, 1200 hours of experience, meets competency requirements, and a Medicaid Provider Agreement.
    - Master's degree,1200 hours of experience, and meets competency requirement

### Provider Requirements (cont.)

- Supports
  - Habilitative Supports Staff 18 years of age, high school diploma or GED
    - Can provide habilitative supports and DDA respite
  - DDA Respite Staff 16 years of age and employed by DDA
    - Can provide respite within a DDA. Can provide respite or adolescent respite.
  - Independent Respite Staff 18 years of age, high school diploma or GED, enroll as Medicaid provider.
    - Can provide respite in the child's home or the provider's home. Can provide respite or adolescent respite.
  - Family Education Bachelor's degree, 1040 hours, and meets competency requirements
    - Can provide family education, habilitative supports, and respite.
