**NOTICE OF INTENT TO SUBMIT WAIVER AMENDMENT  
SOLICITATION OF PUBLIC INPUT**

The purpose of this announcement is to provide notice that the Department intends to submit waiver amendments to the Centers for Medicare and Medicaid Services (CMS) for Idaho's Aged and Disabled 1915(c) Waiver, Adult Developmental Disabilities 1915(c) Waiver, Children's Developmental Disability 1915(c) Waiver and Act Early 1915(c) Waiver.

As applicable to specific waiver authorities, the waiver amendments will include:

- Additions of Home and Community Based Service transition language
- Revisions to person centered planning language to align with IDAPA 16.03.10
- Changes to reflect an expansion of the Medicare-Medicaid Coordinated Plan geographic area
- Updates to complaint/critical incident systems and definitions
- Modifications of assurances, performance measures and data collection to align QA systems
- Clarifications to rate setting methodologies
- Other minor revisions to ensure the waiver accurately captures current processes

Idaho Medicaid is interested in receiving public input regarding the proposed waiver amendments.
