


POST/DNR jewelry is not required but is available through the Idaho End-of-Life Coalition after the doctor completes the new POST form. **IDAHO POST DO NOT RESUSCITATE (DNR) JEWELRY**

An Idaho POST- **Physician’s Order for Scope of Treatment** is a standardized form that allows a person to express his/her treatment wishes in advance of needing medical treatment or emergency situations.



The POST jewelry is **ONLY** for patients that have elected “Do Not Resuscitate” in Section A of their POST form. Please see your doctor and s/he will help guide you through the process of completing an Idaho POST (an Idaho POST must be signed by a physician to be valid).
