

Dear Mr. Shellhous:

In our letter to Encompass Home Health of Western Idaho dated September 5, 2014 we advised you that effective September 20, 2014, we would begin suspension of payments for new Medicare admissions to Encompass Home Health of Western Idaho. Findings from the October 7, 2014 revisit survey by staff of the Idaho Bureau of Facility Standards indicate that Encompass Home Health of Western Idaho is now once again in substantial compliance with Medicare requirements. The termination action has been rescinded and your facility continues to participate in the Medicare and Medicare home health agency program.

Effective September 22, 2014, we are discontinuing the enforcement action against Encompass Home Health of Western Idaho regarding suspension of payments for new admissions. However, the period for suspension of payment was effective for Medicare new admissions made on or after **September 20, 2014 through and including September 21, 2014.**
