SUBJECT: FY 2015 WITS Authorizations

As communicated on 4/24/14, authorizations for IDHW (with the exception of ATR) and IDOC populations were split between fiscal year 2014 and fiscal year 2015. Some authorizations with 7/1/2014 start dates were systematically closed by WITS after 30 days of no activity.

Over the next week, the WITS Helpdesk and BPA will be working to re-open any closed authorizations that started on 7/1/2014 or later as a part of the fiscal year 2015 roll over. This effort will allow us to reinstate the span and units originally authorized. On or after 7/1/14, if you discover that an authorization has not been re-opened, please contact BPA to have it re-opened.

As previously instructed, please do not accept these authorizations until your first visit with the client in fiscal year 2015.

Once the authorizations are re-opened in WITS, they will stay open until August 1, 2014 so that you have time to accept them. It is very important that providers continue to discharge their clients in WITS and send a "Note to Authorizer" to IDHW Contractor or IDOC Contractor to inform BPA of discharged clients, especially while WITS will not systematically close authorizations. Authorizations after 8/1/2014 that have no activity in 30 days will be closed systematically by WITS.
