SUBJECT: IDHW Supervised Misdemeanant Population Implementation 9/1/14

The Division of Behavioral Health is pleased to announce that a new client population, IDHW Supervised Misdemeanant, will be implemented on Monday, September 1, 2014. Funding was allocated to this population to fill the gap in services left by the ramping down of ATR 3. IDHW worked with the Idaho Supreme Court and BPA to develop the eligibility criteria and referral process for this new population, as detailed below.

Supervised Misdemeanants will be referred in to treatment services by Misdemeanant Probation Officers using the Funding Profile Form found on the BPA website (http://www.bpahealth.com/providers/provider_forms). Supervised Misdemeanants with an LSIR score of 18 or higher and a score of 0.4 or higher in the SUD Domain are eligible for referral into the IDHW Supervised Misdemeanant population.

Allowable treatment and RSS services for Supervised Misdemeanants on the IDHW Rate Matrix include all services available for IDHW General Population. Providers in the IDHW network are able to serve this population. Clients in the Supervised Misdemeanant population will be subject to the sliding fee scale. BPA will review all referrals into this population to determine if clients have Medicaid, and follow up with Probation Officers, clients and providers as needed to ensure that clients with Medicaid benefits receive non-Medicaid covered services through SUD Program funding.
