

Service Changes In WITS

EFFECTIVE IMMEDIATELY: Services in WITS have been changed to accommodate bundled services for all funding sources: IDHW, IDJC, IDOC, PSC.

IDJC clients currently have authorizations in WITS for individual services. The current authorizations in WITS for IDJC clients will be expired as of 8/16/2013 and new authorizations will be issued from IDJC for bundled services. **In an attempt to simplify which services to select on an Encounter note for an IDJC client through August 16, 2013, we changed the name of the individual services listed in WITS to have the prefix of IDJC >8-16.** The services listed below will no longer appear on the Encounter Service list drop-down menu after September 15, 2013.

- IDHW – Use the services below for Encounters prior to August 12, 2013.
- IDJC – Use the services below for Encounters prior to August 19, 2013.
- PSC – use the services below for Encounters prior to August 12, 2013.

- IDJC – Use the services below for Encounters starting August 19, 2013.
- PSC – use the services below for Encounters starting August 12, 2013.
