

SUBJECT: NEW PAYMENT RATES EFFECTIVE APRIL 1, 2013

Effective April 1, 2013, the Department is making changes to the reimbursement rates for the service codes outlined below. In accordance with IDAPA 16.03.10.307, the Department calculated the new rates because of the changes represented in our annual Weighted Average Hourly Rate (WAHR) survey.

Services provided on or before March 31, 2013, must be billed separately from the services provided on or after April 1, 2013. There may be an error in your payment if you do not use separate claim forms.

The new rates are listed below by procedure code:
