FREE ULTRASOUND PROVIDER LIST

Idaho Statute 18-609 requires the Idaho Department of Health and Welfare to compile a list of providers, facilities, and clinics that have offered to perform a free ultrasound to any woman contemplating abortion and have requested to be included on the list. Idaho Statute 18-609 states that a patient contemplating abortion has “a right to view an ultrasound image and to hear heart tone monitoring” and “may obtain an ultrasound free of charge.”

The following is a list of providers, clinics, and facilities who have indicated they will provide a free ultrasound to a woman contemplating abortion. This list is updated annually by the Department each January 1st. For the most current list of providers, please visit www.abortioninfo.dhw.idaho.gov.
