

Child Support Visitation Abatement

About the Sworn Statement Regarding Child Support Visitation Abatement

Child Support and Child Support Visitation Abatement are calculated based on overnight stays. Many child support orders provide for an abatement of child support when the child(ren) are with the **Non-Custodial Parent (NCP)** for a designated consecutive time period. The time specified within the order allowing for child support visitation abatement is based on consecutive overnight stays.

In order to grant visitation abatement, your court order must contain language regarding abatement. When discrepancies arise between the parties on the case regarding visitation abatement time periods CSS cannot resolve the discrepancies. CSS will provide abatement according to the court order until parties can have the disagreement resolved.

Idaho Child Support rejects visitation abatement requests for the following reasons:

- Abatement not provided in the support order.
- Actual visitation does not qualify according to the court order.
- Form is not filled out correctly.

You will receive a notice in the mail informing you of the abatement decision.

- If CSS approves your request, visitation abatement is credited on the case. The amount of the abatement is sent to both Custodial and Non-Custodial Parties of the case.
- If CSS rejects your request, your notice includes actions to take in order to grant your visitation abatement request.

Requesting Child Support Visitation Abatement

To request visitation abatement, complete the following steps:

1. Print and complete the sworn statement of Child Support Visitation Abatement form.

Once the statement has been provided to CSS and the dates of visitation changed it is the responsibility of the party reporting to submit an amended statement.
