Open Forum – Steve, Chair

No one expressed an addition or change to the agenda.

<u>HART Model Presentation – Ross Edmunds, Division Administrator for Behavioral Health</u> These are Homes with Adult Residential Treatment. Idaho struggles to meet the needs of individuals who suffer from a mental illness severe enough that they can't live independently, but not severe enough to require hospitalization.

Melissa Wolfe – RALF provider

These homes are being designed to help with residents with psych conditions as opposed to those with Alzheimer's or memory care issues. The reimbursement structure is anticipated to be for PCS (personal care services) and should be of a rehabilitative model. The workgroup has been working on this for two years and combines a home with psychiatric services and could be a long term solution for chronic residents.

This program would provide safe & stable housing funding. Of the six-million-dollar budget request in 2017, the Governor recommended two million. With that money there will be two goals:

- 1. One million will continue the safe and stable funding payments;
- 2. One million will be used to pilot and demo the model possibly 50 beds across the State.
 - a. The homes must be <16 beds:
 - b. There will be 5 10 bed facilities across the State.
 - c. In place of a payment from Behavioral Health, there may be a Medicaid reimbursement for PCS for \$65 day with a care package.
 - d. There will be a need for pre-authorization through OPTUM
 - e. There will be a new licensing category necessary.
 - f. Dual diagnosis will be included.
