

## Upcoming Trainings on Home and Community Based Settings Final Rule

**WebEx:** This will be first come first serve basis; the WebEx will accommodate the first 100 people to log on. The number of callers for the audio portion only is 300 participants. To view the slides on your computer, please try to sit together with staff or other providers to increase access.

All WebEx trainings require you to 1) phone in for the audio and 2) to log onto a computer where you will view slides. The slides as well as an audio recording from all the WebEx trainings will be posted on the HCBS webpage within five business days of each presentation.

**Conference Call:** All WebEx trainings will be repeated as conference calls only to assist those providers who do not have access to a computer/internet or are not comfortable participating in a WebEx. The information will be the same as in the WebEx, it just will be done 100% over the phone without requiring the use of a computer to view the presentation slides.
