Remember...



Idaho has two programs for duals:

1. Medicare Medicaid Coordinated Plan (MMCP) - existing
2. Idaho Medicaid Plus (IMPlus) – new

Duals are participants eligible for Medicare A and B, in addition to full Medicaid

Duals' Programs - Refresher

- We are implementing the new program, [Idaho Medicaid Plus](#), starting on October 1, 2018 in Twin Falls County.
- [Idaho Medicaid Plus](#) will be mandatory for dual eligible participants that have not enrolled in the Medicare Medicaid Coordinated Plan, and are not:
 - Tribal members
 - Pregnant women
 - Participants on the Adults with Developmental Disabilities Waiver
- [Idaho Medicaid Plus](#) will only manage the member's Medicaid benefits (no impact to Medicare coverage)



Outreach Updates

- Provider Fair on June 28 was a success! 50+ providers attended
- Participant Block Party in Twin Falls on August 17
- Additional outreach is being scheduled!

Implementation Update – Enrollment

- Enrollment letters were mailed to affected participants in Twin Falls County on July 1.
- Twin Falls County duals who have not selected a health plan by September 1 will be automatically assigned to a Health Plan.
- Welcome packets will be mailed in September.

Implementation Update – Enrollment

- Around 950 letters were mailed out – but less than 100 members have selected a Health Plan.
- Many participants may be surprised to receive their welcome packets in September.
- Providers who have not enrolled with Blue Cross of Idaho and Molina Healthcare of Idaho may experience billing challenges after participant coverage begins on October 1.

Implementation Update – Member ID Cards

- Remember – members will have different ID cards for the **Medicare Medicaid Coordinated Plan** versus **Idaho Medicaid Plus!**
 - For participants: this means you will receive a new card for your Medicaid coverage.
 - For providers: ensure your billing staff are aware they will begin to see new Medicaid cards

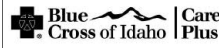

Idaho Medicaid Plus After Twin Falls County

- Idaho Medicaid Plus will expand to additional counties after successful implementation in Twin Falls County.
- Additional counties are expect to go live no earlier than March 1, 2019
- IDHW will be hosting participant and provider Town Hall and informational meetings in October in Idaho Falls, Pocatello, and Blackfoot



IMPlus Implementation - Next Steps

September

- Welcome packets are mailed to affected members in Twin Falls county.

October

- Go-live in Twin Falls County!
- Twin Falls Town Hall meetings – “How is it Going?” – late October
- Participant and provider outreach in Idaho Falls, Blackfoot, Rexburg, Pocatello
- Stakeholder WebEx

November

- IDHW will have data to share on the Twin Falls rollout and Health Plan performance
- Ongoing outreach
