Remember...



Idaho has two programs for duals:

- Medicare Medicaid Coordinated Plan (MMCP) existing
- 2. Idaho Medicaid Plus (IMPlus) new

Duals are participants eligible for Medicare A and B, in addition to full Medicaid



Duals' Programs - Refresher

- •We have implemented the new program, Idaho Medicaid Plus (IMPlus), in Twin Falls County.
- •IMPlus is mandatory for dual eligible participants that have not enrolled in the MMCP, and are not:
 - Tribal members
 - Pregnant women
 - Participants on the Adults with Developmental Disabilities Waiver
- •IMPlus will only manage the member's Medicaid benefits (no impact to Medicare coverage)



Twin Falls County – Challenges and Opportunities

Enrollment Selection

- Enrollment was not processed correctly for a few members (< 1%)
- DHW contacted affected members
- Evaluated enrollment processes to minimize enrollment errors

Member Addresses and Contact Information

- Some letters to affected participants in Twin Falls County were returned as undeliverable
- These members were auto-assigned and enrolled into IMPlus

Provider Billing

- Uptick in Providers reporting problems with billing
- Identified that the majority of reported problems were due to providers not billing the correct entity



Twin Falls County Health Plan Performance – Care Coordination

Metric	Data from Both Health Plans
Number of Care Coordinators	24
Average Care Coordinator Caseload	33 participants/Care Coordinator
Initial Wellness Assessment Completion Rate*	51.5%

Note: This data is for the first month of implementation. Health Plans have up to 90 days to complete initial wellness assessments for new Enrollees.



Twin Falls County Health Plan Performance – Claims

Measure	Data from Both Health Plans
Number of Claims Received	461
Number of Claims Paid	148
Number of Claims Denied	22
Number of Claims Pending	291

Note: This report only shows overall claims activity for the month. Quarterly reports will also include the percentage of claims processed (paid or denied) according to required timelines.

• DHW has received only 1 report of a claim that was not processed timely



Twin Falls County Health Plan Performance

- Complaints: 29 complaints logged, all resolved.
 - 14 provider-related complaints (billing, authorizations)
 - 15 participant-related complaints (communication/outreach)
 - DHW and Health Plans working on strategies to improve these areas for next phase
- Appeals: No appeals filed with either Health Plan.





- Maintain program operations in Twin Falls County
- Phase-in additional counties where there are two participating Health Plans



Ongoing Enrollment in Twin Falls County

- •New dual eligible participants in Twin Falls County will be identified each month and will start their 90-day selection period for Idaho Medicaid Plus.
 - Example 1: I am already on Medicaid and got Medicare this month.
 - Example 2: I am a dual eligible participant and just moved from Boise to Twin Falls.
- In these examples, the enrollment letter will be mailed out January 1 for their coverage to begin April 1.



Program Monitoring


- •IDHW reviews monthly, quarterly, semi-annual and annual reports on the performance of each of our Health Plans for both the MMCP and IMPlus.
- •Report specifications and performance thresholds are outlined in each Health Plan's contract.
 - The MMCP and IMPlus contracts are available for review on our webpage.



Program Improvement

- •IDHW is working on a change to the MMIS to make it easier for providers to identify member enrollment.
- •Health Plan performance dashboard for webpage is under development.
- •IDHW and Health Plans identifying more creative ways to engage participants.
- •Health Plans continually expand their provider networks.





Enrollment Timeline – Next IMPlus Phase

January

90-day selection period begins

April

• Coverage begins

June

 Last month to change Plans until Open Enrollment

Remember!

- Participants have 90 days before coverage begins to make a Health Plan selection.
- If a participant does not notify DHW of their choice, the participant will be automatically assigned to one of the Health Plans.
- Once coverage begins, participants have an additional 90 days to make a change to their Health Plan.
- After 90 days of coverage, participants can only make a change to their Health Plan during Open Enrollment (October-December).
