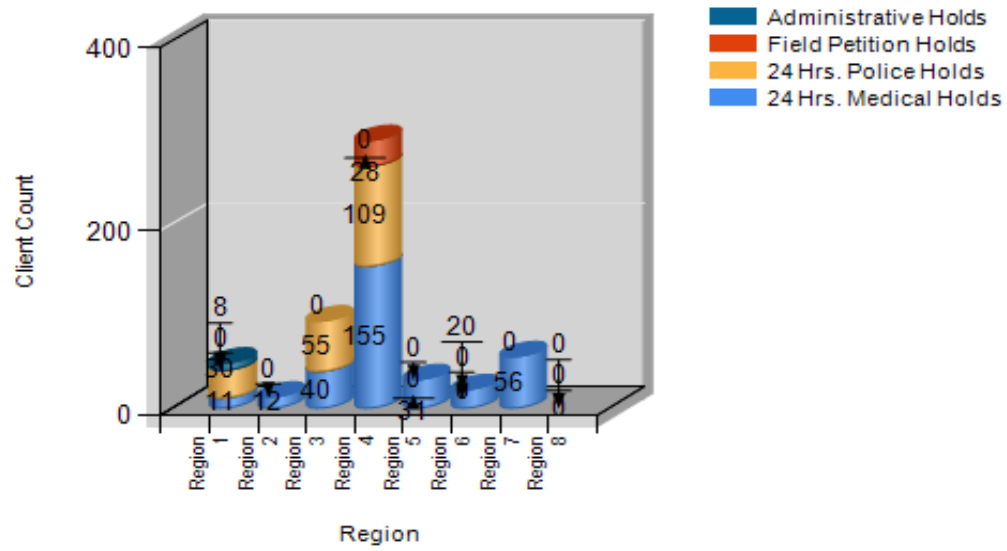

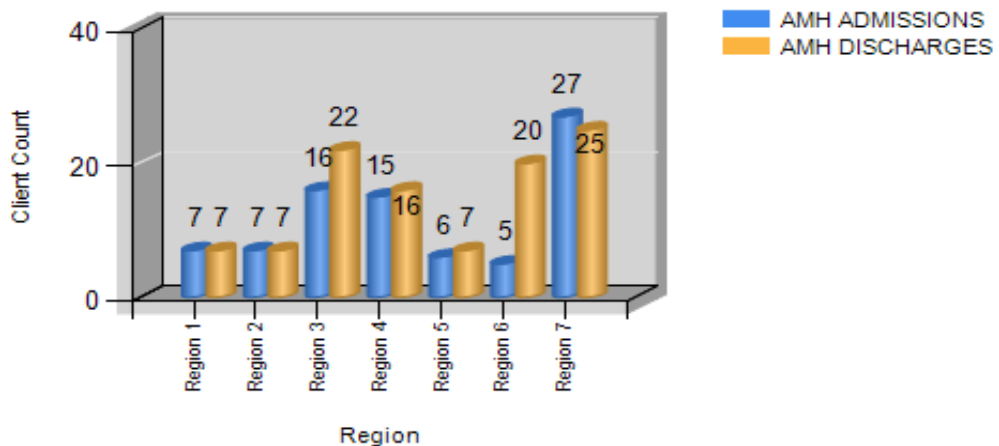

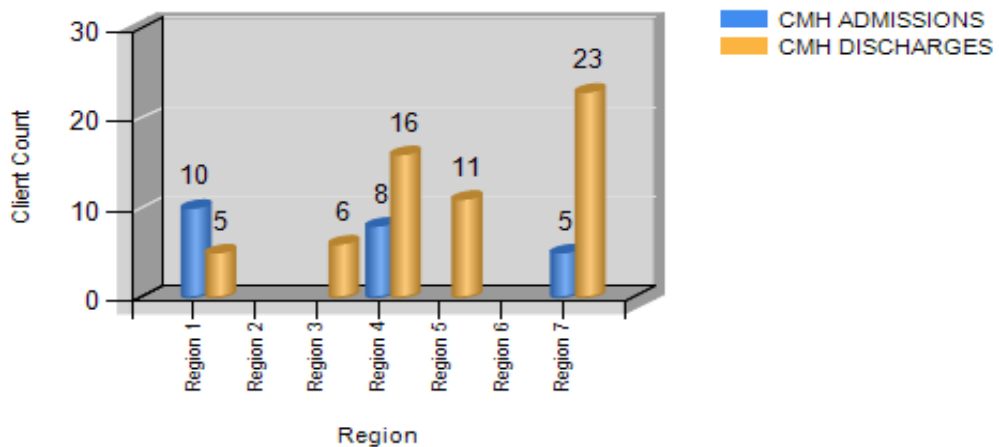
Mental Holds SFY 2020



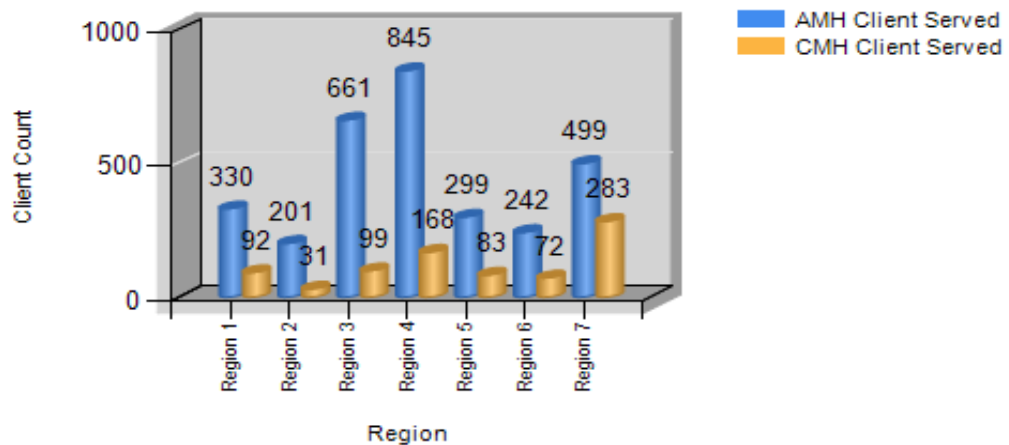
AMH Monthly Admission/Discharge SFY 2020
