SUBJECT: NEW PAYMENT RATES EFFECTIVE July 1, 2018

Effective July 1, 2018, the Department is making changes to reimbursement rates for service codes for Children’s Developmental Disabilities Services. The changes being made are in response to the additional funding allocated for these services by the 2018 Legislature.

Services provided on or before June 30, 2018, must be billed separately from services provided on or after July 1, 2018. There may be an error in your payment if you do not use separate claim forms.

The new rates are listed below by procedure code:

Providers should charge their usual and customary fee for services. Please note that for dates of service on or after July 1, 2018, claims for the above procedure codes submitted by Children’s Developmental Disabilities Service providers will be reimbursed at the fee schedule rate or the rate that is billed, whichever is lower.

Please note, providers do not need to submit plan changes or addendums related to this rate change. Adjustments to participant’s budgets will be automated.
